This past year has been a year of growing our program offerings, board membership, and clinical staff. Thanks to your generous support, the mission of Roanoke Park Counseling remains strong and alive.

We remain steadfastly committed to our specialized therapy services available to every survivor, regardless of their financial need. We believe that every survivor deserves the opportunity to find a new and vital life for as long as it takes to heal.

In this past year, each and every survivor who walked through our doors found a place where they could share their story and find the kind of hope and deep healing that creates meaningful and lasting change.

Lives have been changed and new possibilities for living a full and fulfilling life have become a reality because of you!

We are proud of the place we hold in the community for survivors and for area providers. Roanoke Park Counseling is a reliable and trusted resource for providing experienced and skilled therapy to adult survivors of childhood sexual abuse, and for providing education and support to area providers.

Supporting survivors and providers extends beyond the walls of our offices. During this past year, our

clinical coordinator, Amanda Franklin, M.Ed., LMFT, continued to host a monthly consult group for WA State licensed therapists who work with adult survivors. Ms. Franklin also met with community clinics to offer education and support in treating adult survivors of childhood sexual abuse.

In addition, our annual Fall Professional Event, *Diving into the World of Therapeutic Psychedelics in Healing Trauma*, brought a full house of mental health professionals for an evening of networking, refreshments, education, and lively discussion.

We were delighted to outgrow our previous venue for our annual *Finding Hope, Inspiring Healing* Fall Fundraising Event, held this year at Dukes Dockside on Lake Union – a beautiful and inviting space.

Moving to an evening event offered the opportunity to host a cocktail hour prior to the program, allowing time to connect with our wonderful

supporters. Gathering together to hear the impact of your support in a survivor's life is a highlight of the year. Thanks to you, we set a record amount of \$65,000 to provide healing to survivors throughout the year!

We anticipate continued growth in the coming year by increasing our clinical staff and by adding new members to our board of directors. We feel the energy and momentum of these solid steps of growth and recognize that *these steps are made possible because of those of you who believe in and support our mission to bring healing to survivors and to the community.*

We understand that there is great need in the community – to be a beacon of light and hope for adult survivors and to advocate for the needs of survivors all through the year. We are deeply committed to continuing to provide services of the very highest quality to our deserving clients and to fulfilling our mission.


"It is extremely powerful to experience a safe space where our stories can be held, for me it was the first time I felt truly heard and cared for." ~ RPC client

A true high point of RPC's year is our annual fundraising dinner *Finding Hope, Inspiring Healing*. This event is an important time each year where we invite our generous community of supporters and sponsors to hear firsthand about the hard work survivors do on their pathway to healing.

It is always such a great pleasure to spend the evening with our amazing community of donors whose commitment to survivors makes our work possible. We are able to thank them in person and together to hear the brave and uplifting stories of survivors.

This year survivor speaker Pio Fitzgerald and keynote speaker Margaret Hoelzer, Olympic Silver Medalist and Survivor, shared their stories. Our Emcee once again was Natasha Ryan, Vice President, The North Group. Daryl Redeker, Composer, Musician, and Instructor, shared his gift for guitar. The fall dinner is an important advocacy event for RPC as well as being a fundraiser, and in FY2024 we

Advocacy and Community Education Programs

RPC shines a light on the hidden epidemic of childhood sexual abuse (CSA) by engaging the community through community education and advocacy. As awareness increases and the stigma of sexual abuse decreases, survivors are empowered to step forward to receive life-changing help.

- **MENTAL HEALTH CONSULTATION.** In the past year, RPC's Clinical Coordinator Amanda Franklin hosted a monthly case support group with other mental health providers treating with adult survivors of CSA.
- **PROFESSIONAL EDUCATION.** In November we hosted *Diving into the World of Therapeutic Psychedelics in Healing Trauma*, presented by Marissa Grasmick, LMHC and Jess Flanagan, FNP (Family Nurse Practitioner).
- **ADVOCACY AND COMMUNITY ENGAGEMENT.** RPC hosted a table at the annual Seattle NAMIWalks (National Alliance on Mental Illness) 5K walk advocacy event designed to combat stigma, raise funds, and promote awareness of mental illness.


THE STORY OF HEALING: By the Numbers

Roanoke Park Counseling provides therapy for survivors and their families through individual, family, and group sessions.

Group therapy for survivors includes 10-week introductory groups as well as 21-week process groups. Both types of groups are offered for male-identifying, female-identifying, and GenderQueer adults. We also

host partner support groups (mixed gender) as well as couples counseling. New types of groups have been developed over the years in response to need.

While the majority of the survivors who come to RPC live in King County, thanks to telehealth services, we can accommodate clients joining us remotely from around Washington State.



July 1, 2023 - June 30, 2024


REVENUE OVERVIEW

The work of Roanoke Park Counseling is accomplished by our highly dedicated members of the Board of Directors, together with our clinical and administrative staff. This year we welcomed a new member, Anne Marie Peterson. Anne Marie is a long-time event attendee and who brings a wealth of knowledge and appreciation of the work we do.

Our board members come from diverse backgrounds, including legal services for sexual abuse survivors, with a focus in the field of mental health and a passion for supporting healing therapy and community services through education and advocacy activities.

We also welcomed Nitara Dandapani to our clinical staff. All clinical staff are licensed mental health counselors (LMHCs) or social workers (LICSWs) with master's degrees in psychology, social work, or counseling, and are licensed in Washington State.

RPC has been a national and international voice creating public awareness of childhood sexual abuse for more than 35 years. RPC is the only agency in the Puget Sound area, and one of the very few nationwide, that provides both individual and group therapy that is affordable and allows each survivor services for the length of time it takes to bring healing. RPC staff are active in advocacy events and community education on the crisis of childhood sexual abuse and creating a better world for survivors.


